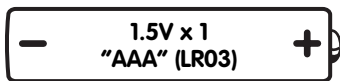
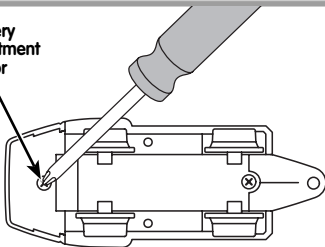

Battery Replacement

For best performance, we recommend replacing the battery that came with this toy with a new "AAA" (LR03) alkaline battery.

- Loosen the screws in the battery compartment door with a Phillips screwdriver. Remove the battery compartment door. Remove the exhausted battery and throw it away. Insert a new "AAA" (LR03) **alkaline** battery.

Hint: We recommend using an **alkaline** battery for longer battery life.

- Replace the battery compartment door and tighten the screws with a Phillips screwdriver. Do not over-tighten.
- If toy begins to operate erratically, you may need to reset the electronics. Remove the battery from the toy and replace it back into the toy.
- When sounds or lights become faint or stop, it's time for an adult to change the battery!



- Protect the environment by not disposing of this product with household waste (2002/96/EC). Check your local authority for recycling advice and facilities (Europe only).

Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your toy. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the toy. Dispose of batteries safely. Do not dispose of the product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the toy before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.
