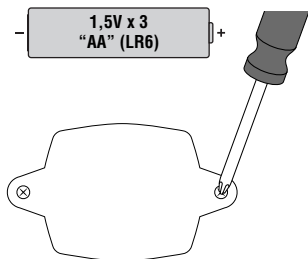
Wipe the toy with a clean, damp cloth. Do not immerse the picnic basket.

Battery Replacement



For best performance, we recommend replacing the batteries that came with this toy with three new "AA" (LR6) alkaline batteries.

- Locate the battery compartment on the bottom of the toy. Loosen the screws with a Phillips screwdriver and remove the door.
- Remove the exhausted batteries and dispose of them properly.
- Insert three new "AA" (LR6) **alkaline** batteries.
- Replace the battery compartment door and tighten the screws. Do not over-tighten.
- If this toy begins to operate erratically, you may need to reset the electronics. Slide the power switch off and then back on.
- When sounds from this toy become faint or stop, it's time for an adult to change the batteries.



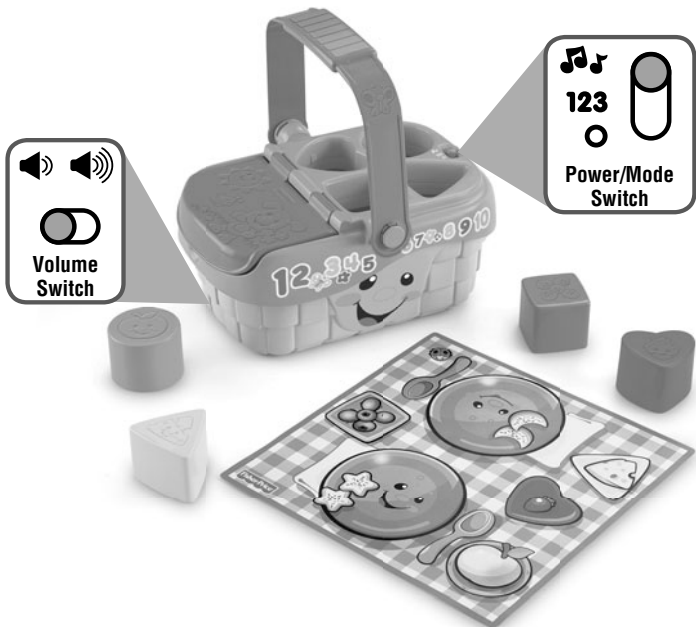

Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Insert batteries as indicated inside the battery compartment.

- **123 Learning** – Lift the basket door to learn about opposites and hear fun sounds. Push the shapes through the matching openings to learn about shapes, colors and more!
