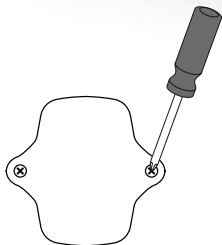

- For best performance, we recommend replacing the batteries that came with this toy with two, new "AA" (LR6) **alkaline** batteries.
 - Locate the battery compartment door. Loosen the screws in the battery compartment door with a Phillips screwdriver. Remove the batteries and properly dispose of them.
 - Insert two, new "AA" (LR6) **alkaline** batteries.
- Hint:** We recommend using **alkaline** batteries for longer battery life.
- Replace the battery compartment door and tighten the screws. Do not over-tighten.

- Slide the switch ON ● or OFF ○ .
- When sounds from this product become faint or stop, it's time for an adult to change the batteries.
- Wipe the toy with a clean, damp cloth. Do not immerse. This toy has no consumer serviceable parts. Do not take apart.
- If this product begins to operate erratically, you may need to reset the electronics. Slide the power switch off and then back on.

Battery Safety Information
