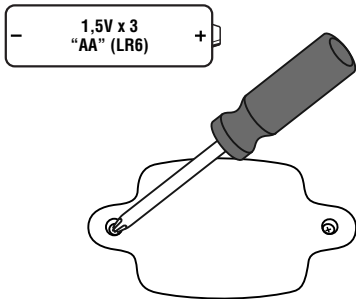
Adult assembly is required for crib attachment.

Requires three "AA" batteries (included) for operation.
Batteries included are for demonstration purposes only.

Tool required for battery replacement: Phillips
screwdriver (not included).

Wipe this toy with a clean, damp cloth. Do not immerse.
This toy has no consumer serviceable parts. Do not take apart.

Battery Replacement



For best performance, we recommend replacing the batteries that came with this toy with three, new “AA” (LR6) alkaline batteries.

- Locate the battery compartment on the back of the toy.
- Loosen the screws in the battery compartment door with a Phillips screwdriver and remove the door.
- Remove the exhausted batteries and dispose of them properly.
- Insert three, new “AA” (LR6) **alkaline** batteries.
- Replace the battery compartment door and tighten the screws.
- If this toy begins to operate erratically, you may need to reset the electronics. Slide the power/volume switch off and then back on.
- When sounds or lights become faint or stop, it's time for an adult to change the batteries.



- Protect the environment by not disposing of this product with household waste (2002/96/EC). Check your local authority for recycling advice and facilities.

Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.

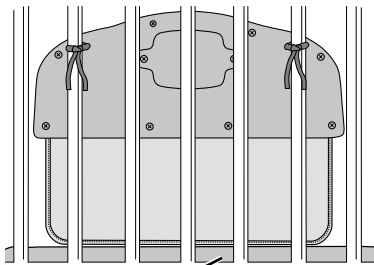
Crib Attachment



WARNING

Prevent Entanglement Injury

- This product may not attach to all crib designs. Do not add additional strings or straps to attach to a crib or playpen.
- Remove this product from crib once the child can sit up unassisted or pull up to a standing position.



Mattress

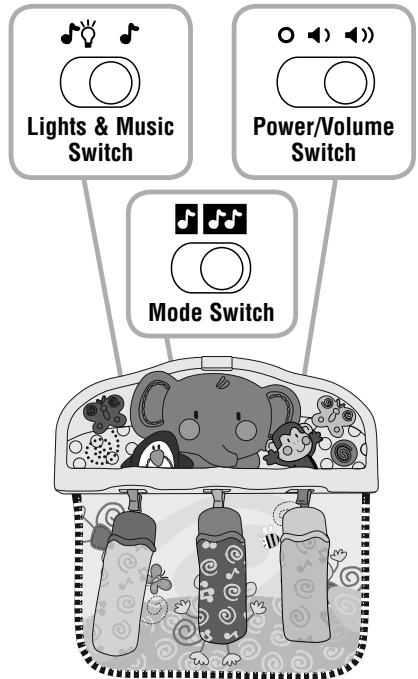
Always attach with all provided fasteners tightly to a crib or playpen according to the instructions. Check frequently.

- Position the toy against the crib spindles/slots and near the mattress.

Hint: For newborns, place the toy along the side of the crib where baby can easily hear and see it. For infants, place the toy near baby's feet.

- Tie each string tightly around a crib spindle/slat. It is better to tie the strings in a knot rather than a bow, since a bow may be easily untied.

2 Modes of Play!



- Slide the *power/volume switch* to ON with low volume ◀), ON with high volume ◀)) or OFF ○.
- Slide the *mode switch* to Short Play or Long Play:
 - 🎵 **Short Play** - Listen to a short ditty when baby kicks the chimes or presses the *start button* Ⓞ!
 - 🎵 **Long Play** - Press the *start button* Ⓞ to play music. Press the button again to switch to a new song. Press and hold the button to turn off music.
- Slide the *lights & music switch* to select lights and music 🎵🔆 or music only 🎵.
