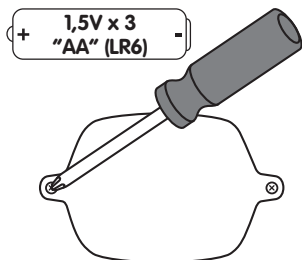
Tool required for battery replacement: Phillips screwdriver (not included).

Battery Replacement



For best performance, we recommend replacing the batteries that came with this toy with three, new "AA" (LR6) alkaline batteries.

- Loosen the screws in the battery compartment door and remove the door.
- Remove the exhausted batteries and dispose of them properly.
- Insert three, new "AA" (LR6) **alkaline** batteries.
- Replace the battery compartment door and tighten the screws.
- If this product begins to operate erratically, you may need to reset the electronics. Slide the power switch off and back on.
- When sounds from this toy become faint or stop, it's time for an adult to change the batteries.
- Protect the environment by not disposing of this product with household waste (2002/96/EC). Check your local authority for recycling advice and facilities.

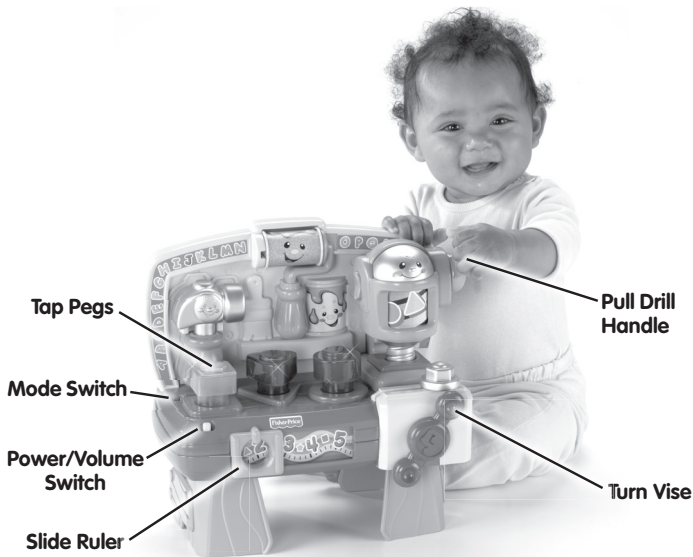


Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of this product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.

Time to Work and Play



- Slide the power/volume switch to ON with low volume (🔊), ON with high volume (🔊) or OFF (🔊).
- Slide the mode switch to Learning **ABC**, Music 🎵 or Imagination 🌀.

ABC Learning Mode

- Tap the pegs to count and hear a tune!
- Pull the drill handle to learn about opposites, ABCs and hear fun phrases.
- Slide the ruler to hear a song about numbers and other fun sound effects.
- Turn the vise handle for songs and sound effects.

🎵 Music Mode

- Tap a peg to hear a short tune. Tap another peg to build a song!
- Pull the drill handle to hear a short ditty.
- Slide the ruler to hear a fun tune.
- Turn the vise handle to hear songs about shapes and colors!

🌀 Imagination Mode

- Tap the pegs, slide the ruler or turn the vise handle to hear fun sounds!
- Pull the drill handle to hear real drill sounds!
