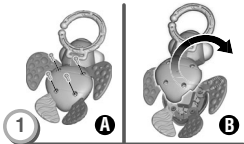

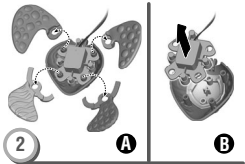

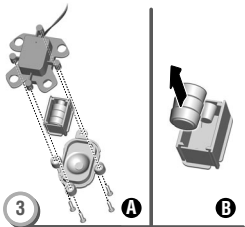
Battery Removal
